

Pastor's Message

A constitution provides for the structure of the organization. It helps serve as a set of rules and principles that all people in an organization can agree upon as the basis of the way in which they want the organization to be governed. Another purpose of the Constitution is to spell out the ideals the members believe their organization should uphold.

I'm writing about a constitution, because member congregations of the North American Lutheran Church (NALC) are asked to adopt a model constitution that helps the congregation function within the norms and expectations of the denomination. Peace adopted the model NALC constitution after joining the NALC. Since that time there have been some amendments to the model constitution that have been proposed by Annual Convocations and ratified by a 2/3 majority of member congregations. So far, these amendments have not been included in our congregation's constitution. It is time to consider whether or not we want to include these amendments in our governing document. The three amendments are:

- The congregation endorses the Confession of Faith of the NALC
- The congregation agrees to call only pastors who are members of the NALC or otherwise authorized by the NALC

The congregation and its pastor (s) are subject to the disciplinary procedures of the NALC These

amendments, which are a series of clauses, will be presented at the Congregational

Meeting in January. While it is not mandatory that we adopt these clauses, not adopting them has ramifications for our ministry. We will be making a statement that we do not desire to operate like the majority of congregations in the NALC. We will remove ourselves from being covered under our denomination's 501(c)3 umbrella. While we will still be recognized as a member congregation of the NALC, we will be on the fringe, not within the mainstream.

I understand the desire at times to want to go my own way, to not be accountable to anyone else. That independent streak has had a history within this ministry. While there are advantages at times, there is something to be said for joining the majority and agreeing on a set of rules and principles for how we are to be governed.

Before adjournment, Jerry thanked the council for his retirement party and for the time spent working on the council.




It was decided that the worship committee would discuss, research and report back to the council in the new year.

Southwest Michigan Interfaith Action-An Interfaith Peace & Justice Collaborative

This past year a group of religious leaders from different faiths (not just different denominations of Christianity) have joined together in an attempt to address some of the issues that plague Southwest Michigan. The collaborative has developed five (5) different working groups; each to address a specific issue. The collaborative is seeking volunteers to staff the working groups which meet every other month on the fourth Tuesdays of even months. Interest in one working group does not mean participation in all groups. If interested, contact Sid Mohn at sidmohn@gmail.com

Green Faith Working Group: (purpose: develop guidelines for faith communities in "greening" their environment)

- 1. Develop a checklist for faith communities to use to "go green". Faith communities who successfully complete the checklist will be awarded a "Green Faith" designation.
- 2. In conjunction with Creation Justice Ministries, Michigan Power and Light, and the Noah's Ark Caucus develop a policy promotion agenda based on our interfaith principles of "care for the holiness of creation".
- 3. Provide worship guides to assist religious leaders in connecting current events to climate change.
- 4. Explore the concept of a summer youth Green Corps to assist with church and community green projects.

<u>Great Waters Working Group:</u> (purpose: promote the stewardship of God's Holy Creation by advancing access to clean water for Michigan residents, preservation of the Great Lakes, and expressing concern about global issues of drought and corresponding poverty/migration)

- 1. Continue research into residential water quality in SW Michigan and identify any correlation between discrimination and poor water quality.
- 2. Monitor establishment of a lead pipe loan fund for low income residents.
- 3. In conjunction with SW Michigan Planning Commission develop a plan to assist in the clean up of Ox Creek (the most polluted body of water in Michigan).
- 4. In conjunction with Great Lakes Conservancy, develop a policy promotion agenda based on interfaith principles.

<u>Dignity of All Working Group:</u> (purpose: addresses situations in which social or economic characteristics of a person are used to exclude, oppress, or deny human dignity and rights — with a particular focus on those most vulnerable.)

- 1. Research anti-bullying policy and program efforts in schools in SW Michigan, and identify and promote best practice models.
- 2. Advance Tiny Houses for Big Change as an opportunity for children in faith communities to understand homelessness and poverty and commit to a shared project.
- 3. Monitor the status of expanded hate crime legislation in Michigan.

<u>No Longer a Stranger Working Group:</u> (purpose: advances faith-based commitments relative to welcoming migrants, refugees and immigrants)

- 1. Explore establishment of a Migration Emergency Assistance Fund with guidance from Berrien Immigrant Solidarity Network.
- 2. Monitor public policies on migration and advance faith-grounded perspectives relative to welcoming the stranger.
- 3. Develop a Spring Educational Series for faith communities, concluding with an Interfaith Prayer Service.

<u>Keep the Peace Working Group:</u> (purpose: addresses local issues relative to gun violence and the threat to human life, and monitors global issues in which violence is directed against persons because of their religion)

- 1. Utilize Interfaith Action's Emergency Response Team to respond to hate crime incidents in SW Michigan.
- 2. In conjunction with Americans Against Gun Violence and the Michigan Coalition Against Gun Violence, establish a faith-grounded policy promotion agenda.
- 3. Contact Michigan congressional representatives with concerns about global situations of violence/war in which the US is involved and in which the conflict includes the violation of human rights of religious groups.

General Collaboration:

General Meetings of Interfaith Action will occur on the 4th Tuesday of the odd months of the year. Working Groups will meet during even months of the year.

The following Interfaith Action themes will be promoted on a quarterly basis during the year — with bulletin/newsletter inserts and worship aids: 1st quarter - migration; 2nd quarter - stewardship of creation; 3rd quarter - dignity of all; 4th quarter - violence and peace.
